GUIDELINES TO CONTRIBUTORS

1. **Language:** The language of the manuscript must be English (British standards).
2. **Originality:** Articles must be original and must not have been submitted for consideration and publication elsewhere.
3. **Abstract:** Provide an abstract of not more than 200 words which briefly summarises the whole content and helps the reader quickly ascertain the purpose of the paper.
4. **Keywords:** Provide 4 to 6 keywords which can be used for indexing purposes.
5. **Title Page:** The title page should include: (i) The name(s) of the author(s), (ii) A concise and informative title, (iii) The affiliation(s) and address (es) of the author(s), (iv) The e-mail address, and telephone numbers of the corresponding author.
6. **Length of paper:** The length of the paper should not exceed 8000 words or 20 pages. Articles should be typed in 1.5-line spacing (footnotes and references should appear in single line spacing) on one side of A4 paper only with wide margins.
7. **Subdivision of the article:** Divide your article into clearly defined and numbered sections. Subsections should be numbered 1, 2. (then 1.1, 1.1.1, 1.1.2), 1.2, etc.). The abstract is not included in section numbering.
8. **References:** Author(s) should adhere strictly to Nigerian Association of Law Teachers Uniform Citation and Documentation Standards accessible at www.naltng.org.
9. The editors reserve the right to effect minor corrections in form and structure of papers submitted for publication
