CAUSES AND EFFECTS OF DIVORCE ON ACADEMIC PERFORMANCE OF PRIMARY SCHOOL PUPILS IN ABEOKUTA SOUTH LOCAL GOVERNMENT AREA OF OGUN STATE

Abstract:

The study examined causes and effects of divorce on academic performance of primary school Pupils in Abeokuta South Local Government Area. The study adopted the descriptive survey design. 100 respondents were randomly selected from 5 School in Abeokuta South Local Government Area of Ogun State A well-structured questionnaire was administered to gather information from the respondents. Mean and standard deviation statistics were employed to answer the research questions raised in the course of the study. Results revealed that, high degree of women has been proven to be involved in divorce which actually affects the children's academic performance. This is based on reason that most of the women cannot single handedly take care of the children economically. It was also revealed that some children living with their father or mother are easily carried away emotionally in class. Finding revealed that domestic violence, infidelity, financial problems, lack of communication, and constant argument are the leading causes of divorce which eventually broke the home of so many families. It was recommended among others that, government and international bodies should make effort to implement harder decree for granting divorce to couples. Likewise there is a need for couples to live within their income, fake life may cause disharmony in the home. In addition, social welfare workers, marriage counselor should also help the youth in our society to prepare them for marriage as most children suffer as a result of broken homes. Lastly, early marriage should be discarded as marriage is meant for two mature minded adults and not for boys and girls.

Introduction:

arents play a major role in life of their pupis, they serve as their role model at early stage of their life. Children always look up to and observe their parents behavior, attitude and character and their steps from a very young age (Dewit, 2019). Throughout childhood, family play a vital role in building pupils attitude, character, behavior, beliefs and expectation. Meanwhile, divorce is process of putting an end to the marriage. Unhappily married parents often struggle with the choice between staying together for the benefit of their children and getting a divorce.

Divorce is a painful and traumatic experience for all those who are involved and it can cause disruption of family life (Giddens& Phillip 2017). Other reasons include infidelity, lack of trust, violence and emotional or physical abuse of substances or alcohol may be contributing factors.

Ayorinde, (2019) explained that divorce is a legal separation of husband and wife so they can be free to remarry again. Ineffective communication, lack of intimacy, infertility, financial status and bad behavior were seen as the major causes, and the result of this divorce lead to poor academic achievement on children of the victims. Divorce is a legal dissolution of marriage by

court or other competent body. It can also be defined as annulment of official separation in marriage. It is observed by the researchers that marriage between a man and a woman is expected to be a permanent affair and lasting association until death takes away one of the partners but changes in the Nigerian society, marriage is now seen to be a temporary affair which can dissolved if either part by cruelty, desertion or adultery goes against the wishes of their union.

Divorce is actually a legal dissolution of marital union which, involve the governance of the marriage bind between a husband and his wife. For a marriage to be successful there is need for a couple to be in harmony mentally, physically and spiritually. In other words, the husband and the wife must have a common goal and each have to contribute his or her own towards the fulfillment in the family and keyword should be love (Cohen, 2016). Parents play a vital role in their pupils' lives, serving as their earliest and most important role model. Children tend to look up to observe their parents behavior from a very young age (Herzog & Cooney, 2016). Throughout childhood, family experiences play a role in building pupil's attitude, beliefs and expectation. (Rogers & Rose 2016) report that children of divorce experience determined sad effects such as depression, anger, aggression, parent-child conflict as well as parental divorce in terms of research, a common question among social scientist regarding children and divorce is how these children are affected by their experience and how they are different from those who are not experiencing ongoing parental conflict and discord. Experiencing parental discord may lead a child to trivialize importance of commitment and view the institution of marriage with negativity (Donald 2015).

According to Mc Donald (2015) as citied earlier on, divorce is defined as the dissolution of a relationship, which is recognized as many relationship. It marked by formal court proceedings and its decree is divorce. Divorce is usually accompanied by formal arrangement owing of property, custody and support of children if there any. The property adjustment may also include a provision requiring alimony to be paid by one partner to the other although alimony is less frequently granted today. Children from divorced families are nearly more likely to suffer damaging mental troubles than those who live with parents. This shows that two parents are much better in bringing up healthy children than one. Children who come from broken home will most likely have difficult time in life. Children of divorced parent are roughly likely to dropout from school than peers who benefit from living with parents who are divorced (Mclannahan, 2016). Some children from broken home are likely to turn to drug abuse or negative behaviors. The fact is that every child needs and deserves the love and care of their both parent. Happy family is the best environment for children. A strong family home is a place where children learn good things and gain the identity, discipline, moral education that are essential for their life and development. Children with divorced parents score lower than children with continuously married parents on measure of academic success (AstoneMclanahan, 2015). The quality of functioning is one of the predictors of pupils' behavior and well-being. Several within group studies shows that either a conflicted relationship or custodial parent are linked with a variety of negative outcomes include lower academic performance, internalizing problems, externalizing problems, reduced self-esteem, and poorer lower competition (Buchnan, Smacco by Dombush, 2016). The effects of divorce on children are traumatic divorce can cause children to question their self-worth, to experience unnecessary grief, guilt or confusion. Young children especially, have difficulties understanding the rationalities of their parents' decision to divorce: In a marriage it is difficult for children to find a sense of security experience shows them that what seemed and good fell to pieces and left them empty. Growing up in a broken home may also cause children to have difficulties in future relationship.

Parental relationship plays a key major role in determining the academic performance of their children in school. Family harmony can easily be affected by parental conflicts. The degree of parental conflicts varies from mild to serious. These conflicts affect the academic performance of their children, hence lead to dropout from school. In their recent longitudinal study, (Harold A, and Shelton 2016) revealed the roles of marital relations and pupils' academic performance. In accounting for the relationship between spouses affects the pupil's adjustment directly through the emotional stress level, role modeling and academic performance (Cumming 2010).

Statement of the Problem

Divorce leads to negatively affected parental involvement in their children's school work, which leads to young pupils who come from parental divorce feeling unwanted and not loved by one of their parents. This usually leads young children expressing anxiety and anger at the same time. A child might begin to blame his father for divorcing his mother, which may lead to a relationship breakdown between father and son. Young children may feel they are not protected by both parents, therefore, lead them to find a place where they feel they can be protected such as staying in a foster care. Some eventually commit crime and drop out from school because of lack of guidance. RECOMMENDATIONS

Based on the outcome of the findings, the following recommendations were raised;

- 2. Government should set up marriage counseling Centre across the board to ensure that parents accommodate each other.

- 4. Others like social welfare workers, marriage counselor should help the youth in our society to prepare them for marriage as most children suffer as a result of broken homes.
- 5. Early marriage should be discarded as marriage is meant for two adults mature minds, not for boys and girls. Maturity will helps the couples to bear and forgive one another as conflicts arise among couples.
