Guidelines for Contributors

1. Language- The language of the manuscripts must be standard British English.
2. Originality- Articles must be original and must not have been submitted for consideration and publication elsewhere. Please note that the submission of paper is an express consent to transfer all copyright of the author to THE POLYNEK JOURNAL OF LAW, TECHNOLOGY AND INNOVATION (PJLTI) Department of Social Sciences, School of General Studies (SGS), Federal Polytechnic Nekede Owerri Imo State Nigeria.
3. Abstract- Should not be more than 250 words which briefly summarize the whole content and would help the readers quickly grasp the purpose of the paper.
4. Keywords- Provide 4 to 6 keywords which can be used for indexing purposes.
5. Title Page- Should include—(i) the name(s) of the author(s); (ii) concise and informative title of the paper; (iii) institutional or industrial affiliation(s) and address(es) of the author(s); (iv) e-mail address and telephone number.
6. Length of Paper- Should not exceed 6000 words or 15 pages in Times New Roman in Microsoft Word format. Shorter noted e/g. book, case or statute review should not exceed 10 pages. The Article should be typed in 1.5-line spacing (footnotes and references should appear in single line spacing) on one side of A4 paper only with wide margins. Text size is 12 while footnote is 10. The footnotes shall be automatic.
7. Subdivision of the Article- Into clearly defined and numbered Sections. Subsections should be numbered 1, 2 (then 1.1; 1.1.1; 1.1.2, etc.) The Abstract is however not included in Section numbering.
8. References and Documentation- citations are as follows:
  - a. Books- Author's surname, initials, title of book in italics, edition, place of publication, publisher, year of publication, page number
  - b. Journals Author's surname, initials, title of article in inverted commas, volume number, year in bracket, Title of journal in italics, page number.

- c. Cases Name in full and italics, year reported in bracket, volume of law report, page number
- d. Statutes Full name, year of enactment
- e. Sections of law In italics
- f. Online sources Should indicate the author, title, site and date of visit.
